SIR State BYLAWS 2023

Sierra SIR Branch No. 77 - follows the most current SIR Manual and Branch Bylaws as presented in the SIR State Webpage (https://sirinc.org/manual)

SIERRA SIR BRANCH 77 POLICIES 2024

1) Branch Executive Committee (BEC)

- A. The BEC consists of a possible total of 12 voting members: Big Sir, Little Sir, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, and 6 Directors.
- B. Branch Directors shall serve one-year terms and be restricted to three consecutive terms, excluding any partial year immediately preceding the first such year. If a Branch Director vacates the position for one or more calendar years, eligibility is reestablished. Directors are encouraged to hold a branch role- e.g., as Chairman of Recruitment, Activities, Member Relations, Publicity& Image, or Membership.
- C. BEC will meet at the Sonora Elks' Lodge on the same day as the luncheon meetings and may be altered by the BEC for special events
- D. The BEC will approve an annual branch calendar for the Nine Regular Luncheon Meetings and the Three Member and Guests Events.

2) Monthly Meetings

- A. There are 12 scheduled Branch 77 events each calendar year. Nine of the twelve events are Regular Luncheon Meetings. Three of the twelve events are for members and guests, and they are: The Spring Ladies Day Event, the Summer BBQ/Picnic Event, and the December Holiday Banquet Event.
- B. Sierra Sir Branch 77 monthly meetings occur on the Second Thursday every month and may be altered by the BEC for special events
- C. The Branch will pay once for a guest's lunch if that guest is a potential member.
- D. The Branch will pay for speaker's and presenter's lunch

- E. The BEC may raise, or lower lunch prices based on various budgetary concerns (e.g., inflation, caterer charges, member attendance, etc.).
- F. Background: There are 12 scheduled Branch 77 events each calendar year.

3) <u>Membership</u> SONS IN RETIREMENT, SIERRA SIR BRANCH NO. 77 (CA 501c4 Corporation #101723)

A. The specific purpose of this corporation is to operate an organization for the enjoyment of its members as a means of promoting the objective of Sons In Retirement, Incorporated, the meeting of a civic need by providing for the welfare of retired men from all walks of life in their pursuit of a common goal, the enjoyment of their later years with dignity and pride, by assisting these senior citizens in renewing former friendships and associations and providing them an opportunity to make new friends through association with other retired men who also face the particular problems that confront men upon their retirement. The assets of the organization are irrevocably dedicated to the foregoing purpose.

4) Branch membership in good standing.

- A. Background: There are 12 scheduled Branch 77 events each calendar year. Nine of the twelve events are Regular Luncheon Meetings. Three of the twelve events are for members and guests, and they are: The Spring Ladies Day Event, the Summer BBQ/Picnic Event, and the December Holiday Banquet Event.
- B. Membership in good standing: Considerations
 Item #1 <u>Current</u> Branch 77 members must: 1) be up to date with his Branch 77
 annual dues that are paid-in-full by the end of February of each year, and 2)
 Minimally attend 3 of the 9 Regular Luncheons Meetings each calendar year to be eligible for Branch 77 membership in good standing.

Item #2: New Branch 77 members (that are not transfers from active membership in another branch) must 1) Pay any applicable membership dues with badge fees, and 2) Have attended at least 3 branch meetings since joining Branch 77 before being eligible for Branch 77 membership in good standing.

Item #3: <u>Transfers</u> to Branch 77 that are transferring as active members in another branch must 1) Pay any applicable membership dues with badge fees, and 2) (a) Have attended at least 3 Branch 77 meetings or (b) Show that they have attended 3 branch meetings in their previous branch over the past year, before being eligible for Branch 77 membership in good standing.

5) Propane Program Requirements

- A. The Annual Branch 77 Propane Program starts on April1 of each year
- B. Branch individuals must have Branch 77 membership in good standing to be eligible to participate in the Propane Program
- C. Eligible individuals are Added To, or Removed From, the Propane Program in April of each year
- D. Individuals may be removed from the Propane Program at any time 1) If they are no longer a member of Branch 77, and 2) If they have not maintained their Branch 77 membership in good standing
- E. The Branch BEC may vote to determine if a member that has not, or cannot
- F. The BEC may vote annually to admit or continue a member in the Propane Program who is unable to attend luncheon meetings due to prolonged illness, acting as a care giver to a family member or an extended absence from the Branch locale. A member who is granted attendance relief is still a member and subject to Branch Regulations

6) Dues and Badges

- A. The BEC will annually determine branch membership dues, and may raise, or lower dues based on various budgetary concerns throughout the year (e.g., inflation, member attendance, subsidies). Honorary Life Members (HLM) are exempt from paying dues
- B. All current members will renew their annual dues in January and February of each year to maintain their branch membership. The BEC may vote to adjust dues for certain members as deemed appropriate.
- C. All new members added throughout the year are subject to the full dues amount for the first 9 months of the year. All new members that join in the last three months of the year are exempt from paying branch dues. The BEC may vote to adjust dues for certain members as deemed appropriate.
- D. All branch members are required to purchase a new or replacement name badge and wear the badge at all events. If a member forgets his badge a temporary badge will be provided. The BEC may vote to adjust the cost of a name badge for certain members as deemed appropriate.

7) Activities

- A. All SIR Branch activities to be covered by insurance must submit a Sierra SIR Branch 77 Activity form for annually approval by the BEC
- B. Sierra SIR Branch NO. 77 elects to be covered by the provisions of California Corporation Code Section 5239. (7-7-22)
- C. All SIR-sponsored approved activities including team sports of any kind can be regulated, limited, or cancelled by any authorized State, County, or local health department.

- earned it The HLM is not to be treated lightly or awarded merely on the basis of good fellowship.
- C. Distinguished Service Award (DSA) This "Silver Lapel Pin" award is the 2nd highest award in SIR, to recognize exceptional/extraordinary service at the Branch and/or State levels. This award is to provide a level of recognition for their members that have not earned that which an HLM award requires but have been highly contributing to the success of the Branch and have: been a member for a period of 3 years or more. clearly earned it through exceptional and extraordinary service. steps forward whenever the need arises would be recognized by his peers to have earned it The DSA is not to be treated lightly or awarded merely on the basis of good fellowship.
- D. SIR Branch 77 to develop procedures, policies, and membership requirements for identifying and awarding HLM and DSA candidates. Completion 1st quarter 2024

9) SIR I'm Doing My Part Award (Pin)

SIR State Policy#10 Item #3

- A. "I'm Doing My Part" Award- This lapel pin award is for Branches to provide special recognition for their members that have not earned the level that a DSA or HLM award requires but have been contributing to the success of the Branch. Branches shall establish their own individual criteria for candidate selection and approval but keeping in mind the need to recognize all members that volunteer as it's these members that a Branch cannot survive without.  - c. BEC Non-Voting Members: Membership Chair, Chaplin, Activity Chairs (golf, bowling, hiking, TBD), Web Master, Bulletin Editor, Event Chairs, and others TBD
